MEEP Grant Application 163/2020 Hagan:

That the Administrator submit an application to the Municipal Economic Enhancement Program (MEEP) for the following projects:

- Administration Building Roof Project To upgrade and restore the roof of the Municipal Administration Building by removing dilapidated shingles, roof repairs as required and then reshingling with Legacy Melarky architectural shingles; and that this project will be cost shared with the Town of Govan; and that project funding requested for this project will be \$10,000.
- Farm Access Upgrades To upgrade and enhance approaches by widening them to accommodate large modern farm machinery; and to further enhance seasonal dirt roads by building up low spots to provide better access to remote property; and that project funding requested for this project will be \$15,000.
- Road Grinding Project To renew and rehabilitate approximately 3.2 km of road surface by grinding 4 to 8" deep and then to incorporate a clay-gravel mix in the surface, to pack it and then top with road gravel; and that project funding requested for this project will be \$14,525.
