Local State of Ag Disaster 162/2021 Flavel:
That pursuant to Section 20 of The Emergency Planning Act, Chapter E-8.1 of the Statutes of Saskatchewan, effective immediately the Council of the R.M. of Last Mountain Valley No. 250 declares that a "Local State of Agricultural Disaster" exists throughout the entire municipality; and further that drought conditions are impacting 50-90% of cereal and oilseed yields as well as 50-90% of hay, pasture and range yields due to lack of spring and in-season moisture combined with long duration periods of high temperatures and dessicating winds.
